AGREEMENT

In consideration of Seller, Shamrock Building Materials, Inc., selling goods and/or services to the Buyer executing this application and agreement, Buyer (and Guarantor, as applicable; Buyer and Guarantor are hereinafter referred to collectively as "Buyer") agrees to the following terms and conditions regarding all purchases made hereunder:

- 1. All purchases shall be paid according to terms indicated on invoice. If the terms indicate a cash discount is allowed, the discount will be honored on prompt payment only. No discount will be allowed on invoices considered past due. All sales subject to timely availability of product from manufacturer. Buyer waives any dispute of any invoiced amount if such dispute is not presented to Seller within ten (10) days of receipt of said invoice by Buyer.
- 2. In the event that full payment of an invoice is not received by the due date indicated thereon, Buyer agrees to pay a late payment fee on the Past Due Amounts at the rate of one and one-half percent (1½%) per month, or the maximum permitted by law, whichever is less.
- 3. Buyer agrees to pay Seller's reasonable attorney's fees, expenses, and court costs, including fees, expenses, and costs in bankruptcy or on appeal, if Buyer's account is referred for collection and enforcement to an attorney. Buyer consents to personal jurisdiction in Oregon and venue in Washington County. Buyer agrees that Seller may increase or reduce the amounts of credit it is willing to extend without prior notice to Buyer. This agreement may not be modified except in writing signed by both parties.
- 4. The undersigned acknowledges that a facsimile or e-mail signature shall be as binding as an original signature.
- 5. Seller's liability in any claim, demand, or action arising out of this Agreement, or related to the products financed hereunder, shall be limited to the benefit received by Seller attributable to such financing.
- 6. Buyer warrants and represents that the information contained in this Agreement, including the Credit Application, which is a part of this Agreement, and any other information provided by Buyer which Seller has relied upon in order to extend credit under this Agreement, is true, correct, and not misleading, and agrees that any credit extended by Seller to Buyer will be pursuant to this Agreement.
- 7. Buyer authorizes Seller and its agents to obtain credit information of any kind concerning Buyer from anyone. Buyer authorizes all of its creditors to provide information of any kind to Seller about Buyer. Buyer authorizes Seller to provide credit information about Buyer to any of Buyer's creditors or potential creditors.
- 8. All payments received by Seller on Buyer's account shall first be applied to accrued interest, and then to other costs, and then to principal.
